# Catching Up With George Denison P'57

This semester James Davis, Jr. catches up with George Denison, currently working as a Lobbyist in Washington, D.C.

**James Davis, Jr.:** What is your favorite Alpha Delta Phi memory?

George Denison: The most memorable part of my Alpha Delta Phi experience was getting to know all the brothers of the house, many of which I still talk to. Michigan is such a large school, but joining a fraternity made the University much smaller and gave me an extremely close circle of friends.

**James Davis, Jr.:** What was the best or most memorable football game you ever attended, and what made this game the best?

George Denison: I would say the most memorable is far from being the best game of my career. It was in November of 1955 and Michigan was ranked number 1 in the country for the whole season. The last game of the year was against Ohio State. It was a cold and snowy day. The Wolverines lost in a bitter match against Ohio State. Not only was suffering this loss huge, but losing this game gave Michi-

gan State the opportunity to represent the Big 10 in the Rose Bowl.

James Davis, Jr.: What did you study in school? Is your current career related to what you studied?

George Denison: For my undergrad I studied Political Science at the University of Michigan. I then went on to law school at the Detroit College of Law, which ironically enough is now MSU. After law school I went on to work for Senator Goldwater in Washington, D.C. My major of political science and then law school definitely relate closely to my career today.

**James Davis, Jr.:** If you could give any advice to your freshman self, what would you say?

George Denison: I mostly would have done it all the same if I went back to freshmen year of college. I loved the big school of Michigan, but I would advise freshmen to look into fraternities as a great way to meet a smaller group at a large school. I would tell my freshmen self to be sure to join an organization that will help you meet a closer group of friends on a massive campus.


**James Davis, Jr.:** If you have been back to the house recently, how does it compare to what you remember?
